Actual Results	<p>The allocation primarily went to fund the Martin County Water Planner, Rich Perrine, for his time presenting information and reporting on the County Water Plan.</p> <p>Martin SWCD spent time on education and outreach, including the Martin County Fair, the District website, their weekly radio program, and putting together its twice-a-year County wide Conservation Update. Staff also put on the District's annual Environmental Awareness Day for every 5th grader in the County.
